



LWOP WALK FOR LIFE 2024 is organized by the incarcerated members of the **2nd Chance 2 Society for LWOPs** group at Valley State Prison (VSP). 100% of net proceeds will be donated to Shriners Children's™ Northern California. We proudly support Shriners Children's™, which provides all aspects of care for children with orthopedic conditions, spinal cord injuries, burns, and cleft lip and palate, regardless of the families' ability to pay. This event is scheduled for **Sunday, June 2<sup>nd</sup>, 2024**. It is slated to take place on VSP's main yard as well as in the gymnasium. A snack bar with food and drinks is planned. A range of outdoor sports competitions have been organized for incarcerated residents. Circle T Ranch has offered to bring in horses that attendees can pet and feed.

The gymnasium is reserved for an EXPO of organizations for LWOPs, justice reform, re-entry resources, and rehabilitation. LWOP WALK FOR LIFE 2024 **EXPO** will bring together organizations in support of Shriners Children's™ and will help incarcerated individuals make connections that will aid in their successful rehabilitation and reentry. Incarcerated residents will have the opportunity to visit booths and get the information they need.

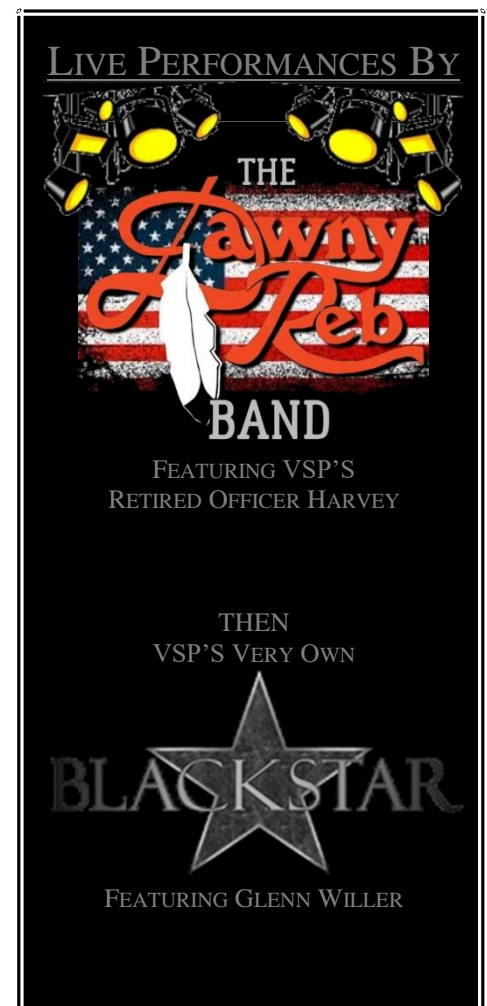
